

# **MUN Resolution Example**

Use this Resolution as an example to help guide you when constructing a resolution with your sponsors

### **Resolution Structure:**

#### Structure:

Sponsors: Delegates who you who have worked with into building this resolution Signatories: Delegates who are NOT part of your resolution group but who have seen your solutions within this documents

Preamble - This section is designated to address all aspects of the topic of the committee. 4 or 5 clauses. Must start with with a preambulatory clause. Refer to Resolution Clause list for preambulatory clauses. Think of the preamble like a thesis in an essay but chopped up

- 1. Operatives A detailed approach to combatting or solving a piece of the topic at hand. Should have atleast 4 operatives in a resolution. MUST start with an operative clause. Refer to Resolution Clause list for operative clauses
  - a. Sub-Operatives Clarification and/or extra details of the operative
    - i. More Information detailing the operative

For an example resolution, go to the next page (Fun Fact: The following Resolution is from 2015 North Country Regional Model United Nations in the UNOOSA committee regarding Access to Space. It was actually developed partially by Secretary-Operations Christian DeMesa who represented Russia.)

## Resolution Example:

Sponsors: The United Republic Of Korea, Cuba, Mexico, Russia, China

Signatories: Spain, Argentina, Australia, Kazakhstan

Reminding all nations of the 5 International Treaties (Outer Space Treaty, The Rescue Agreement, The Liability Convention, The Registration Convention, and the Moon Agreement)

*Noting* with satisfaction, past efforts by other countries advanced in space exploration in furthering the development of humanity

*Stressing* the fact that UNOOSA is the only united organization of nations in concert to collaborate in the exploration and colonization of space

- 1. *Encourages* all relevant space agencies and nation's governments of UNOOSA to work in conjunction with one another;
  - a. Calls upon an independent, international space agency that monitor all activities in space and inspects spacecrafts before launch. The agency could also vote to create and amend space laws for the good of humanity;
- 2. *Urges* all nations to help contribute to the resolution of climate change before focusing on further colonization beyond Earth;
  - Reminds all nations that the Outer Space Treaty and the Moon Agreement bans all claims whether governmental or organizational, to any extraterrestrial territory and confirms it as the property of all mankind;
  - Requests all nations to have a long-term plan to clean up all debris in space that is supported by the International Space Agency;
- 3. Noting that nations can use private and government agencies to explore space;
  - a. Recognizes that small, developing countries may not have all the resources to carry out a successful space mission by themselves;
  - Promotes competition among private companies in order to advance technology and innovate as fast as possible;
  - c. Endorses the plan of S.T.A.L.I.N. (Space Total Access Leans International) to help further the advancement of small and developing countries to access to space in the future through economic loans through the World Bank as part of its Millennium Development Goals;

- 4. *Calls* upon all nations to join together in research and development of advanced space technologies to make accessibility more widespread in both costs and ingenuity;
  - a. Requests all nations to participate in the Damocles Institute which shall be situated in neutral Switzerland to call upon the united efforts of every nation's great leading figures in science and technology
- 5. *Supports* the idea of stating the ownership of any territory beyond Earth as the property of all mankind:
  - a. Recommends a process for the choosing of persons of space colonization be based on significance of persons involved based on profession, variety of ethnicity, and chance lottery as an opportunity for all
  - b. Endorses the collaboration of all future space colonies with one another and necessitate responses to calls for aid or assistance in the case of emergencies.
